

Hartford, Connecticut (September 24, 2012) To celebrate our freedom to read, Hartford Public Library, American Civil Liberties Union, and the Law and Government Academy at Hartford Public High School will present a *Banned Books Readout* on Monday, October 1st at 6:00 p.m. at Hartford Public Library's Mark Twain Branch, located in Hartford Public High School at 55 Forest Street. Light refreshments will be available at 5:30 p.m. John Dankosky, WNPR News Director and Host of *Where We Live*, will moderate the program.

"Banned Books Week is designed to draw attention to the fact that, despite the First Amendment's sweeping protection of free speech and expression, misguided fears of ideas have led to censorship throughout our country's history," said Andrew Schneider Executive Director of the ACLU-CT.

Some of the most popular books in the United States, including titles such as Maurice Sendak's children's' book *In The Night Kitchen*, have been challenged or banned from schools and libraries. Ray Bradbury's *Fahrenheit 451* was censored for years to make it more acceptable for use in schools. *The Perks of Being a Wallflower* by Stephen Chbosky has been compared to *Catcher in the Rye*. Both books have been removed from schools and libraries due to their content and subject matter.

To draw attention to banned books and in celebration of the freedom to read, *Banned Books Week* has been observed since 1982. This year it is being celebrated September 30 – October 6.

Matthew K. Poland, chief executive officer of the Hartford Public Library said, "The Library is delighted to be collaborating with the ACLU and the Law and Government Academy to celebrate the freedom to read, one of the hallmarks of a free and open society. This has never been more important than it is today in light of current world and national events."

The October 1 event will feature prominent members of the community reading passages from their favorite banned books. Readers will include Dr. Christina Kishimoto, Superintendent, Hartford Public Schools, Secretary of the State Denise Merrill, Hartford City Councilwoman Cynthia R. Jennings, Luis Caban, recently retired Executive Director, Southside Institutions Neighborhood Alliance, Deacon

Arthur Miller, Director, Office of Black Catholic Ministries for the Archdiocese of Hartford, and Tiffany Mitchell, Senior at Law and Government Academy, Hartford Public High School.

Adam Johnson, Principal of Law and Government Academy said, "It's very important in today's environment to expose our students to the issues of censorship and the freedom to read. Being directly involved with the October 1 program is a great opportunity for our young people."
