What information do I need to provide?

- Birthdates for all family members who need coverage
- Social Security Numbers for all family members who need coverage (or document numbers for legal immigrants)
- Citizenship or immigration status
- Tax return for previous years
- Employer and income information for every member of your household who needs coverage (for example, from pay stubs of W-2 forms-wages and tax statements)
- Health care coverage information (policy numbers for any current health insurance plans covering members of your household)
